**RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

In consideration of being permitted to participate, attend, observe, work for, officiate, or be involved in any way in any Raging Bull Texas Stampede events or activities, I, for myself, my personal representative, heirs and next of kin:

1. Hereby release, waive, and discharge the Raging Bull Texas Stampede and its organizers, promoters, sponsors, participants, instructors, rescue personnel, advertisers, owners and lessees of premises or events and for each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "Releasees," from all liability to me, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned arising out of or related to the events, whether caused by the negligence of the Releasees or otherwise. In addition, I covenant not to sue any of the Releasees based upon any claim arising out of any of the events.
2. Hereby assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the events whether caused by the negligence of Releasees or otherwise.
3. Hereby agree to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage or cost they may incur due to claims brought against the Releasees arising out of my injury, or death, or damage to my property while attending, teaching, practicing, observing, or working for or for any purpose participating in the events and whether caused by the negligence of the Releasees or otherwise.
4. Hereby acknowledge that the events are potentially very dangerous and involve the risk of serious injury and/or death and/or property damage. I also expressly acknowledge that injuries may be compounded or increased by negligent rescue operations or procedures of the Releasees.
5. Hereby agree that the car will be operated by a licensed driver, and that the driver will comply with all applicable provisions of the Texas Motor Vehicle Code. I further warrant that I carry automobile liability insurance on the vehicle, meeting or exceeding all Texas statutory requirements and that this insurance will be in full force and effect on the date of this event. I will not participate in this event under the influence of any alcoholic beverages or other drug or drugs which would impair my ability to perform at this e.
6. Hereby agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the events are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
